

## MINORS (UNDER 18 YEARS OLD)

Dear applicant,

If any documents are marked with NO below, your application for a visa for Denmark is <u>incomplete</u>. You are requested to hand in the missing/required documents to VFS within <u>5 days from today</u>. If the Embassy has not received the documents by this deadline, the decision will be based on the information available. *Missing documents may negatively affect the visa decision*. Please note that the Embassy may still ask for additional documents and/or call your parents for an interview. Caller ID shows as 'unknown'.

Required documents provided when handing in application:	YES	NO
Correctly signed application form by both parents – printed and signed ApplyVisa cover letter.		
<b>Signed current passport</b> (+ copy of all pages) – issued within the last 10 years, have two blank pages and be valid for at least 3 months beyond your intended stay in the Schengen area.		
If available, previous passport – all previous Schengen visas and stamps must be provided.		
Original birth certificate with both parents' names  - If one parent has sole custody or guardianship of the minor: Birth certificate mentioning one parent <u>OR</u> Death certificate of absent parent <u>OR</u> Court ruling.		
<b>Proof of UK residency</b> (BRP and/or Share code) – valid for 1 month beyond your intended stay in the Schengen area.		
<b>Travel and medical insurance</b> – covering the requested travel dates and be valid for the entire Schengen area. Must cover COVID and emergency medical expenses, hospitalisation and repatriation for the minimum sum of €30.000.		
<b>Proof of sufficient funds for the stay</b> – original UK bank account statements showing the balance and your full name, covering the last 3 calendar months – approx. £40-60 per day - When sponsored by a parent: Sponsorship letter + parent's bank statements as per above.		
+ when applying together with only one parent or without any parent/guardian:		
Original passport of both parents (or ID cards with signature) - If applicable, parents' residence permit/share code for proving UK immigration status		
Written consent for issuance of visa from both parents/guardian(s): Please be aware of the following rules in the UK: Get permission to take a child abroad - GOV.UK		
British school certificate / Letter of enrolment from UK school		
<b>Proof of purpose of trip</b> – e.g. flight/hotel reservation, signed and dated invitation from host in Denmark or other reliable documentation. Must state purpose and dates for the intended stay.  - We recommend that you do <u>not</u> buy any tickets before your visa has been approved.		

If your application is <u>received at the Embassy less than 15 calendar days</u> before your intended travel date, the **Embassy can deem your application inadmissible**. If so, the Embassy will NOT process your visa application and your passport and documents will be returned to you and the visa fee refunded.
