



Please use this checklist if you are only applying for a visa for Greenland and/or the Faroe Islands. If you are also applying for a Schengen visa, please see the [relevant checklist](#) for a Schengen visa.

If any documents are marked with **NO** below, your application for a visa for only Greenland and/or the Faroe Islands is **incomplete**. Please arrange with VFS to hand in the missing documents **within 5 calendar days from today**. If the documents have not been received by this deadline, the decision will be based on the information available.

You will be informed when a decision on your visa application has been reached or if further information is needed. **Missing documents, declining to provide further documentation or not making yourself available for interview when asked may negatively affect the visa decision.**

| <b>Correctly signed application form</b> – Printed and signed ApplyVisa cover letter. Signature must match the one in your passport  |     |    |
| <b>Signed current passport</b> (+ colour copy of all pages) – issued within the last 10 years, have two blank pages and be valid for at least 3 months beyond your intended stay   |     |    |
| <b>Proof of UK residency</b> (e.g. Immigration Share Code) – residency must be valid for 1 month beyond your intended stay in the Schengen area.   |     |    |
| <b>Proof of sufficient funds for the stay</b> – original bank statements showing the balance and your full name and address, covering the last 3 calendar months – approx. DKK 350-500 per day<br>- If sponsored by spouse: Marriage certificate + sponsor letter + spouse's bank statements<br>- Minors sponsored by a parent: Birth certificate + sponsor letter + parent's bank statements  |     |    |
| <b>Proof of purpose of stay</b> (+ dates of intended stay) – e.g. flight/ferry/hotel/cruise reservations, itinerary or invitation from host in Greenland/Faroe Islands. Invitations must be dated, signed, explain the purpose of stay and contain the host's contact details<br>- <b>If your flight/ferry/cruise reservations show transit in the Schengen area, you must also provide copy of your valid Schengen visa</b> (alternatively, provide explanation on how you will obtain a Schengen visa valid for the given period)<br>- <b>We recommend that you do <u>not</u> buy any tickets before your visa has been approved</b> |     |    |
| <b>Minors (under 18 years) – the following documents must also be provided:</b>  |     |    |
| <b>Original birth certificate for the minor with both parents' names</b><br>- If one parent has sole custody or guardianship of the minor: Birth certificate mentioning one parent <b>OR</b> Death certificate of absent parent <b>OR</b> Court ruling   |     |    |
| <b>Original passport of both parents</b> (or ID cards with signature) + residence permit, if applicable  |     |    |
