⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 225 shall be charged per statement.

⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,640 shall be charged for the first passport and DKK 1,130 or DKK 1,782 for subsequent passports.

⁷⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,770 shall be charged for the first passport and DKK 1,130 or DKK 1,782 for subsequent passports.

⁸⁾ The fee may increase to EUR 135 or EUR 180 if an implementation decision has been adopted in the EU in accordance with the Visa Code Article 25a. Does not apply to children up to and including eleven years of age.
